It is therefore expected that during 7th edition of Pariksha Pe Charcha - 2024, students of classes 6th to 12th, teachers and parents of Kendriya Vidyalayas will participate in Online Competition to frame Multiple Choice Questions (MCQ) which has already been started from 12th December 2023 and will continue up to 12th January, 2024. They are also advised to frame their questions to address the Hon'ble Prime Minister of India for this event.
